Annual Fee for use of the dog park shall be determined by resolution of the Town Board.

Use of the "Halfmoon Scentral Bark Park", hereinafter ("the Park"), is subject to the Rules and Regulations for use attached hereto. Any violation of the Rules and Regulations may result in the termination of your right to utilize the Park, and/or citations by the Animal Control Officer. **Please carefully read & sign the attached Rules & Regulations, as well as Safety Guidelines.** The Town Clerk's Office will issue the tags for use of the Park and distribute the Rules and Regulations for use of the Park, as directed by the Town Board. A copy of the signed application shall be retained in the Town Clerk's Office.

Anyone using the Park shall do so at their own risk. Dogs must wear Municipality Dog License Tag when utilizing the Park. The Town of Halfmoon shall have no liability for injury or damage to the dogs or people using the Park. Any information provided is used solely to assist residents in safely in using the Park and does not imply an expertise or acceptance of any liability on the part of the Town of Halfmoon.

Permittee hereby WAIVES ANY RELEASES AND ALL CLAIMS for damages that may arise from permittees use of the Park for off leash dog walking that permittee has or may have in the future against the Town of Halfmoon, its officers, employees, agents, or Animal Control personnel (all of whom are hereinafter referred to collectively as "THE RELEASES"). The Permittee hereby consents to WAIVE ANY AND ALL LIABILITY for any loss, damage, expense or injury including death and that the permittee, any person supervising the authorized pet, or the pets themselves may suffer DUE TO ANY CAUSE, CLAIM, OR UPON ANY THEORY WHATSOEVER, INCLUDING CLAIMS FOR NEGLIGENCE, PREMISES LIABILITY, ADEQUACY OF SUPERVISION, OR ANY OTHER CAUSE OF ACTION OR THEORY.

Permittee hereby agrees to INDEMNIFY AND HOLD HARMLESS the Town of Halfmoon and all RELEASEES from all costs, damages, suits, claims of any kind brought by another person by reason of Permittees use of the Park pursuant to this permit, and to the fullest extent of the Law.

I, _____ have read, and agree to comply with the Rules and Regulations for the use of the Scentral Bark Park as a condition to obtaining a tag for use of the Park. I further hereby acknowledge that there are risks to myself and my dog(s) associated with the use of the Park and I agree to hold the Town of Halfmoon harmless for any damages I may incur as a result of my use of the Park, without conditions or exceptions.

Human Rules

USE AT YOUR OWN RISK-Owners are legally responsible for the actions and behavior of their dog at all times.

DOG WASTE MUST BE CLEANED UP IMMEDIATELY.

OWNERS MUST BE WITHIN THE DOG PARK AND SUPERVISING THEIR DOG(S) AT ALL TIMES. UNATTENDED DOGS WILL BE SUBJECT TO TRANSPORT TO THE SARATOGA COUNTY ANIMAL SHELTER BY ANIMAL CONTROL

OWNERS ARE LIMITED TO NO MORE THAN THREE DOGS PER VISIT.

THE TAG ISSUED FOR USE OF THE PARK IS NONTRANSFERRABLE.

OWNERS MUST CARRY THEIR LEASH WITH THEM AT ALL TIMES.

ALL DOG HANDLERS MUST BE 16 YEARS OLD OR OLDER.

CHILDREN 5-15 YEARS OLD MUST HAVE ADULT SUPERVISION.

CHILDREN UNDER 5 ARE NOT PERMITTED IN THE DOG PARK.

OWNERS MUST FILL IN ANY HOLES DUG BY THEIR DOG(S).

OWNERS MAY BRING WATER AND A BOWL FOR THEIR DOG(S) TO USE.

OWNERS MAY PROVIDE TRAINING TREATS TO THEIR DOG(S).

OWNERS MUST MAINTAIN CURRENT RABIES VACCINATIONS AND RECORDS CERTIFYING THAT VACCINATIONS ARE CURRENT.

THE DOG PARK IS SUBJECT TO ALL OF THE RULES, REGULATIONS AND PROCEDURES GOVERNING TOWN PARKS EXCEPT AS SPECIFICALLY MODIFIED HEREIN.

THE DOG PARK MAY NOT BE USED FOR BUSINESS PURPOSES WITHOUT EXPRESS WRITTEN CONSENT OF THE TOWN OF HALFMOON.

ALL PLAY AND EXERCISE EQUIPMENT IS FOR USE BY DOGS ONLY

Dog Rules

WITHIN THE FENCED CONFINES OF THE DOG PARK, DOGS MUST BE OFF-LEASH. EVERYWHERE ELSE THE LEASH LAW REMAINS IN FORCE-This includes the parking area.

ALL DOGS MUST HAVE BOTH CURRENT RABIES VACCINATIONS AND CURRENT DOG LICENSES AND MUST HAVE THEIR TAGS DISPLAYED UPON THEIR COLLARS AT ALL TIMES.

NO DOGS ARE TO BE LEFT UNATTENDED IN VEHICLES OR TIED TO FENCING.

The Following are Prohibited:

- Human or Dog Food
- Glass containers
- Dogs in heat
- Sick dogs
- Aggressive or muzzled dogs
- Dogs under 4 months old
- Spike, chain, prong or electronic collars
- Smoking
- Alcohol use

Enforcement of the above rules is under the immediate supervision of the Town Animal Control Officer, his or her designees and/or assigns. Violation of the above rules is subject to all fines and penalties as set in local laws and ordinances and may also lead to the termination of your right to utilize the Park and forfeiture of any fees paid.

IN AN EMERGENCY DIAL 911 FOR SARATOGA COUNTY SHERIFF DISPATCH.
